The App links directly to the SOC to ensure that every step of the open, close and service process is completed safely. Data collected by the system is downloadable for reporting and audit. Together, the systems improve branch safety, reduce costs, and provide comprehensive reporting and documentation of security protocols.

Improves Branch Safety

- Staff safely perform **automated and assisted** Branch Open, Close and Service from their smartphones
- If trouble arises, **staff accesses assisted video, call or chat** during activity - contacts 24/7 Monitoring Center for immediate support
- Monitoring Center receives **visual and audible indicators of trouble**
- Trouble notifications can be sent **automatically and covertly** to keep staff safe
- **Staff are notified** of branch activity via App notifications...confirms that branch is safely opened and can be used for emergency notification

Documents & Reports Security Protocols

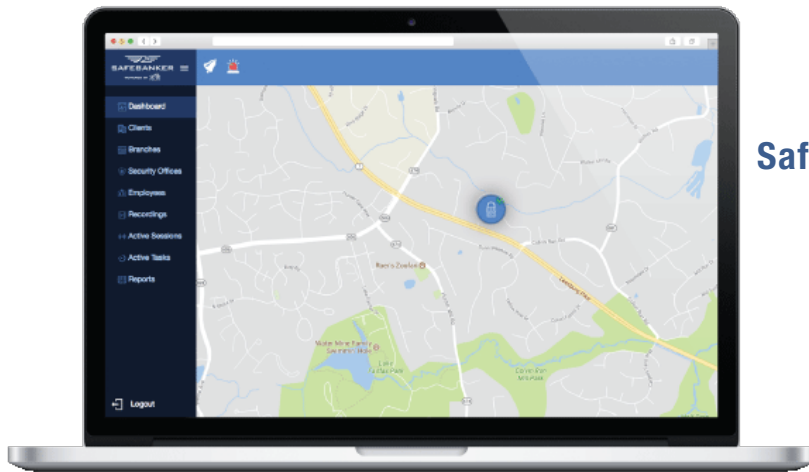
- App **records all open/close/service activity** and saves all information for easy future access

- **Geofence around branch** ensures activity is completed at the branch location
